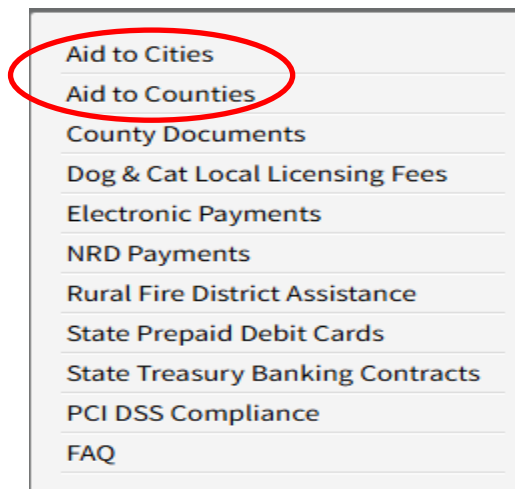
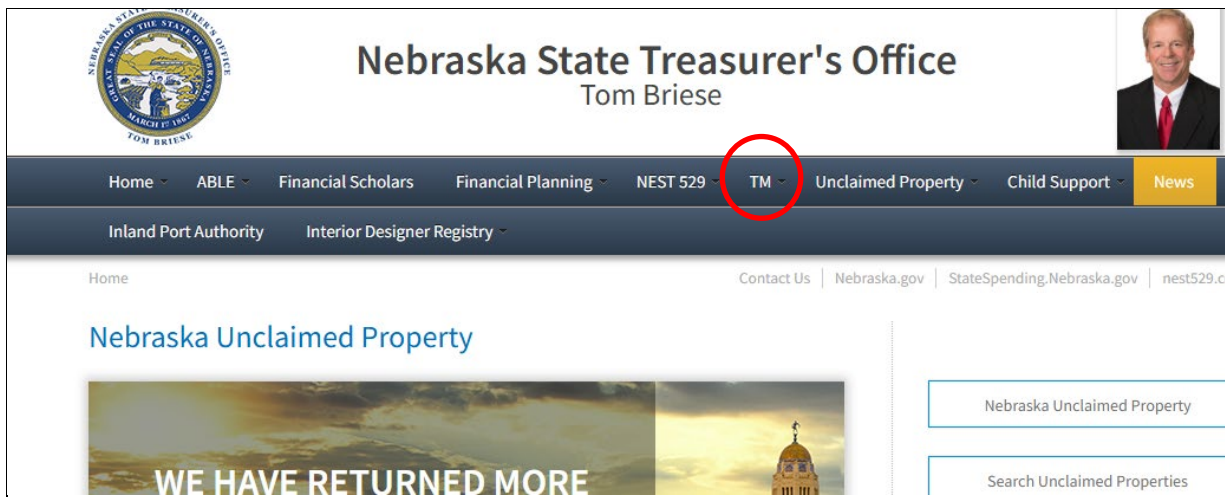
To verify the distribution of monies issued by the state, to municipalities and counties.
